I/we agree to relinquish all AKC papers and medical records.

I/we agree to pass on all pertinent information regarding the dog, including history and temperament.

Upon transfer of possession of the dog from Owner(s) to a WSSH representative, Owner(s) relinquish all interest, claims and rights, financial and otherwise. WSSH will not be required to notify Owner(s) of the status or location of the dog at any time, including but not limited to the placement of the dog.

Upon transfer of the dog to a WSSH representative, Owner(s) agree to hold WSSH and all its representatives harmless regarding the dog.

In the event that you change your mind about relinquishing your dog to WSSH, you and your family will be subject to the same conditions, scrutiny, fees, and reference checks as any regular adopter. No exceptions.

Should a dispute arise over terms and enforcement of this contract, the parties agree to submit the matter to Arbitration before filing suit. The decision of Arbitration shall be binding on the parties and the cost of Arbitration shall fall on the party seeking to dissolve this agreement or its terms.

Owner(s) understand that WSSH holds no element of confidentiality regarding this release form. It will be treated as public record, available to all persons upon request.

This contract represents the complete agreement for surrender of the dog. All of the information provided on this agreement is, to the best of my/our knowledge, true and complete. By signing below, the parties agree to this contract.
